While many things are different this year, one thing has not changed: teachers and staff of North Elementary School are committed to achieving excellence and putting students first each and every day. During a traditional school year, academics has been our top priority. This year, many more layers of considerations guide our way of work - students' health and wellness being the very first thing that we address when students arrive at our campus. We recognize that students have been separated from the traditional learning for some time, and we are glad to be able provide some normalcy for both of our students and staff behind the classroom doors. With that being said, delivering two modes of instruction (face to face and virtual) on one campus and in some instances in the same classroom is a challenge for everyone. We would like to thank all families for their patience as we navigate through these uncharted waters.

We are almost done with our first round of iReady diagnostic assessments, and we will be presenting the first set of school data at our School Advisory Committee meeting on Thursday, September 10. We know that there are gaps to fill, but with everyone working towards one common goal, we are determined to set all students up for success!

We have changed the homework expectations due to the fact that some students are learning from home all day - making additional homework inapplicable. With that being said, there are several things that all students can do at home. We encourage students to read a minimum of 20 minutes each day to build fluency, aid with reading comprehension, and to develop a rich vocabulary. AR tests are also available after school hours this year. For math fluency, we recommend students to practice their math skills online on Reflex Math website (www.reflexmath.com).



iReady additional lessons are available online, but we do not recommend students to spend more than 45 minutes on iReady per week, per subject. iReady lessons can be accessed through students' portal at

https://launchpad.classlink.com/okeechobee.

Parental involvement and communication is important to us. One change this year is that we do not use students' agendas to minimize the number of things that go from school to home and vice versa. Since most communication takes place online, we ask that all families sign up for their child's homeroom teacher's Class DOJO, and ensure that there is a current e-mail on file with school.
