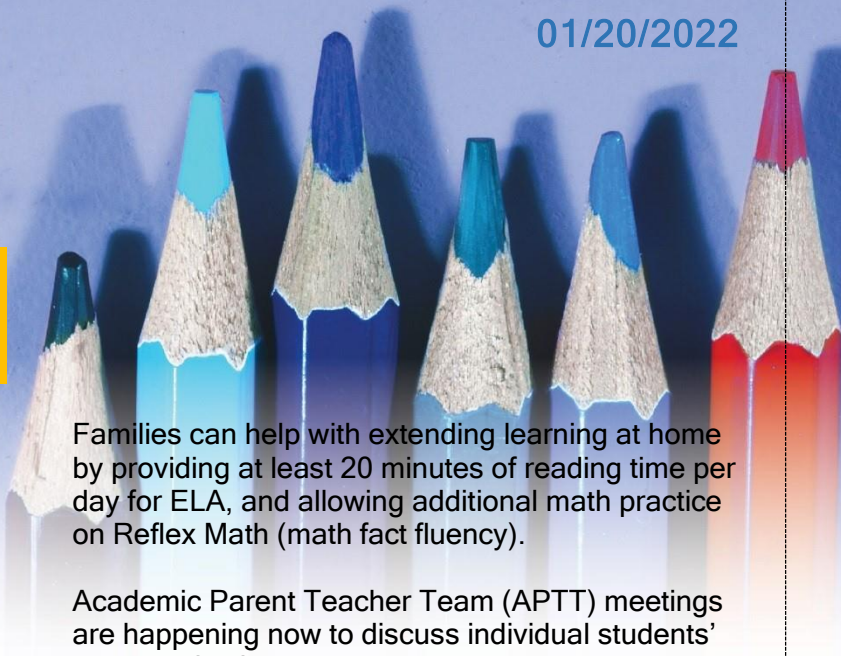

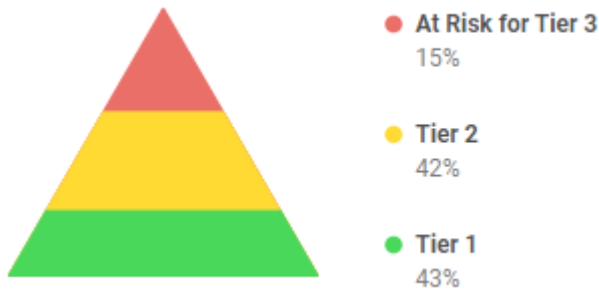


DEAR NES FAMILIES,

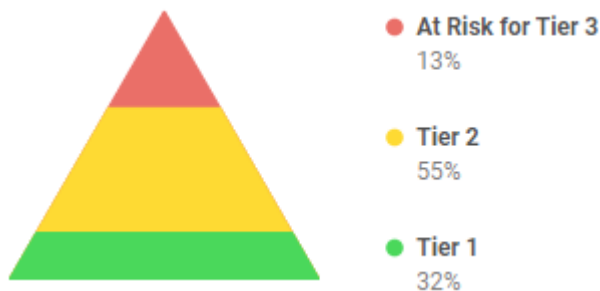
Thank you for a great first half of the school year! We appreciate the partnership in our efforts to provide the best learning opportunities to all students!

Academic Parent Teacher Team (APTT) meetings are happening now to discuss individual students' progress in class.

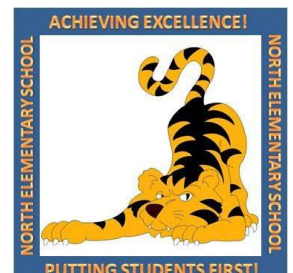
